# Call for an expert group on digital competences and digital capacity in youth work

Deadline for applications: 14 December 2021, 12:00 CET

Erasmus+ and European Solidarity Corps Agency in Estonia as the Lead Coordinator of Work Package 2 "Digital competences and capacity in youth work", part of Strategic National Agencies Cooperation project "Digital Youth Work", is looking for a group of 4-6 experts to support the work of Work Package 2 on the topic of competence and capacity building on digital youth work, as detailed below.

#### **Context:**

WP 2 builds on the outcomes of the EU Council Conclusions on <u>Smart Youth Work (2017)</u>, <u>Digital Youth Work (2019)</u>, as well as of the expert group set under the <u>EU Work Plan for Youth 2016-2018</u>.

Main objective: contribute to a holistic view of the current digital state and support the capabilities of youth work organisations, youth workers and trainers, in order to advance their objectives for a successful digital transformation in the field of youth work. During September-November 2021, a wide mapping has been carried out at national and transnational level, to identify:

- 1. Digital competence models/frameworks for youth workers and trainers
- 2. Digital capacity models/frameworks for youth work organisations
- 3. Self-assessment tools for digital youth work
- 4. Training materials for digital youth work (after 2018)

In order to ensure that the findings resulting from the mapping process are carefully taken into account, the Expert group will contribute to integrating collected information and provide recommendations for future directions and tools - developing an online self-assessment tool for youth workers/trainers and youth work organisations.

The work of the Expert group will be reflected in the European report on digital competences & digital capacities in youth work, produced by WP2.

## **Profile of the experts**

The criteria below are not cumulative - experience of each expert can be linked with all or just some of the criteria listed.

- have a strong **knowledge of the youth sector** in Europe
- have a good understanding of digital youth work practices at the national and/or European level
- have a good understanding of what is digital transformation and how this could be applied in the youth sector (for youth workers, educators and/or for youth work organisations) or other related fields
- have experience with implementing, assessing or designing competence frameworks in the youth or educational sector





- have experience with designing, assessing or implementing self-assessment tools in the youth or educational sector - for youth workers and/or youth work organisations
- have good analytical skills can analyse information and provide recommendations based on it
- have a strong command of English as a working language (written & spoken)
- have a strong capacity to use online digital tools (shared documents, communication tools etc.)

## **Tasks for the experts**

- Analyse and provide detailed feedback to the information gathered by WP2 coordinator mapping done at national and European level
- Draft the conclusions & recommendations for the European report on digital competences & digital capacities in youth work (written contribution)
- Actively contribute to the discussions & meetings organised
- Provide written feedback to the proposed documents, including the final report

- Be available to attend and contribute to 3 online meetings (3 hours each)
- Be available to work online independently and in groups (using shared documents & folders) 4 working days
